All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville; tract known as "the corner lot on the west side of the Holliday road, a county road leading from State Highway No. 14 by the old Ansel School, being shown on a plat made for L. Hatt Strickland and Margaret H. Strickland by John A. Simons, Surveyor, dated August 3, 1950, recorded in the R.M.C. Office for Greenville County, and having the following corners and dimensions:

S.E. corner on a nail in the center of said road (iron pin on bank thereof 22 feet from true corner), and runs thence with the center of said road, N. 34°55' E. 289.7 feet to a nail, corner with Clarence L. and Jeannette J. Mitchell; thence with their line, S. 63°45' E. 290 feet to an iron pin; thence N. 58°15' W. 122 feet to an iron pin; thence S. 64°56' W. 126 feet to an iron pin; thence S. 63°15' E. 57 feet to an iron pin; thence S. 63°15' E. 50 feet to the beginning corner.
