TO ALL WHOM THESE PRESENTS MAY CONCERN: JACK BRIGGS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand Four Hundred ----- DOLLARS (\$ 12,400.00), with interest thereon from date at the rate of six (6%) per centum per annum; said principal and interest to be repaid in monthly installments of Eighty-nine and no/100 ---- Dollars (\$ 89.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents; the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, located on the northwest side of East Perry Road and being the greater part of lot No. 14 or 80 feet frontage thereof and 10 feet from the northeast side or frontage of lot No. 15 as shown on a plat of property entitled "Leawood Hills", made by Terry T. Dill, surveyor, dated October 1958, made for Homer Styles and E. H. Batson, and having the following courses and distances, to-wit:

Beginning at a new corner on the northwest side of East Perry Road in the front line of Lot No. 15 at a point N. 43-22 E. 90 feet from the joint front corner of lots 15 and 16 and running thence N. 43-22 E. 10 feet to the joint front corner of lots 14 and 15; thence along the northwest side of said road N. 43-22 E. for an additional 80 feet to a new corner; thence a new line N. 46-38 W. about 112.36 feet to a new corner on the line of the Floyd Estate property; thence S. 43-15 W. 90 feet along said estate property to a new corner in the line of lot 15; thence S. 46-38 E. about 112.18 feet through lot 15 to a point on the northwest side of said road and the beginning corner.

This loan is insured by the Mortgage Guaranty Insurance Corporation and it is understood and agreed that at the expiration of 10 years from the date of this mortgage, Fidelity Federal Savings and Loan Association may at its option, apply for insurance for an additional five years with Mortgage Guaranty Insurance Corporation, and the mortgagor will pay to Fidelity Federal Savings and Loan Association a premium for such insurance of 1/2 of 1% of the principal balance then existing; and this agreement and covenant shall be binding on myself, my heirs, successors and assigns.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
