NINE AND NO/100THS - - - Dollars (\$129.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes; insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aformal debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Huntington Road in or near the town of Mauldin, being shown as Lot 31 on a plat of Knollwood Heights recorded in Plat Book GG at Page 152 and described as follows:

BEGINNING at an iron pin on the western side of Huntington Road 355 feet north from McDaniel Lane at the corner of Lot 30 and running thence with the western side of said Road, N. 32-15 E. 180 feet to an iron pin at the corner of Lot 32; thence with the line of said lot N. 55-15 W. 187 feet to an iron pin in the line of Lot 26; thence with the line of said lot, S. 30-47 W. 179.9 feet to an iron pin at the corner of Lot 30; thence with the line of said lot, S. 55-11 E. 183.2 feet to the beginning corner.
