JAMES H. TRAMMELL

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand Eight Hundred and No/100ths

DOLLARS (\$ 10,800.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being on the Northeastern side of Pine Knoll Drive, Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 8 as shown on a plat of Property of Eloise M. Bailey, Section 1, prepared by Dalton & Neves, dated May, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book DD at page 183, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Pine Knoll Drive at the joint front corner of Lots Nos. 8 and 9, and running thence with the line of Lot No. 9 N. 59-17 E. 152.4 feet to an iron pin in the line of property now or formerly of Eloise M. Bailey; thence with the line of the said Bailey property S. 41-0 E. 101.7 feet to an iron pin on the Western side of an unnamed street; thence with the Western side of said unnamed street S. 77-55 W. 10.4 feet to an iron pin; thence continuing with the Western side of said unnamed street S. 63-29 W. 96.6 feet to an iron pin; thence still continuing with the Western side of said unnamed street S. 49 W. 22 feet to an iron pin; thence with the curve of the intersection of said unnamed street and Pine Knoll Drive, the chord of which is N. 86-0 W., 35.3 feet to an iron pin on the Northeastern side of Pine Knoll Drive; thence with the Northeastern side of Pine Knoll Drive N. 41-0 W. 75 feet to the point of beginning.
