ALL that certain piece, parcel or lot of land, with all improvements thereon, or horeafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Strawberry Drive, known and

- designated as Lot No. 28 on plat of Blue Berry Park recorded in the R. M. C. Office for Greenville County in Plat Book "BB", at Page 18, and having, according to said plat, the following metes and bounds, to-wit:
