All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the City of Greer, in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 2, Addie W. Long Property, as shown on a plat thereof prepared by Madison H. Woodward, dated December 18, 1963, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book FFF at page 25, and having according to said plat the following metes and bounds:
