WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

**being known and designated as lot # 4 on a plat of NORTH HAMPTON ACRES recorded in the RMC office for Greenville County in Plat Book YY at Page 63 and having according to said plat the following metes and bounds, to wit:**

**BEGINNING at an iron pin at the northwest corner of Falcon Drive and Reids School Road, and running thence with the northern side of Reids School Road, S. 65-54 W. 220 Feet to iron pin, corner of lot 3; thence with line of said lot, N. 24-06 W. 310.4 feet to iron pin in line of lot 5; thence with the line of lot 5, N. 79-53 E. 252.4 feet to iron pin on Falcon Drive; thence with the western side of said Drive, S. 20-21 E. 52.6 feet and S. 23-38 E. 177.4 feet to iron pin, corner of Reids School Road; thence with the curve of the intersection, the chord of which is S. 21-08 W. 28.4 feet to the beginning corner.**
