WHEREAS, James & Marie Roberts

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville about two and one half miles from the Greenville County Court House, just off Old Pendleton Road at the intersection of Arch Street and Graceland St. and having the following metes and bounds according to Plat by C. C. Jones, November 20, 1952.

BEGINNING at an iron pin at the intersection of Arch Street and Graceland Street and running thence with Arch Street N 26-25 W 58.4 feet to an iron pin; thence S 42-25 W, 102.2 feet to an iron pin thence S 42-20E 66 feet to an iron pin on Graceland Street, thence with Graceland Street N. 31-55 E 84 feet, more or less to the beginning corner.
