NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the West side of Terrace Circle in Simpsonville, being Lot 4 on plat recorded in the R. M. C. Office for said County in Flat Book EE at pages 64 and 65, described as follows: BEGINNING at iron pin on West side of said street, joint corner with Lot 3, South 68-01 West 190 feet to iron pin, thence South 21-59 East 92.5 feet to iron pin thence North 70 East 190.2 feet to iron pin, thence along said street North 21-59 West 99.4 feet to the beginning.

The foregoing lot was conveyed to grantors by deed of George Webb, December 6, 1957, recorded in the R. M. C. Office aforesaid in Deed Book 589 at page 70.
