All that certain piece, parcel or lot of land being known and designated as Lot No. 7 of Block F of a subdivision known as "Woodville Heights", according to a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book K, at Page 273, and as is more fully shown on a plat of property of Jack R. Hollingsworth, prepared April 29, 1964, by C. C.
