ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon situate, lying and being on the East side of Sewanee Avenue, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot 48 on Plat of White Oaks Subdivision of Northside Development Company, made by J. D. Pellett, Jr., Engineer, August 1946, recorded in the R. M. C. Office for Greenville County, S.
