WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

DOLLARS

(\$ 7800.00), with interest thereon at the rate of **Five & One-Half** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **15** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

within the corporate limits of the City of Greenville, being known and designated as all of lot No. 18 and the northern one-half of lot No. 19, of a subdivision known as Vista Hills, recorded in the RMC office for Greenville County in Plat Book P at Page 149, and described as follows:**"BEGINNING at a point on the northwestern side of Ridgecrest Drive, at joint front corner of lots Nos. 17 and 18, said point being 335 feet southwest of the northwestern intersection of Wayne Street with Ridgecrest Drive, and running thence N. 69-15 W. 170 feet to point at joint rear corner of lots Nos. 17 and 18; thence S. 16-45 W. 112.5 feet to a point; thence S. 69-11 E. 164.3 feet to a point on the northwestern side of Ridgecrest Drive; thence with the northwestern side of Ridgecrest Drive, N. 20-45 E. 112.5 feet to the point of beginning."****Being the same property conveyed to the mortgagor by deeds recorded in Book of Deeds 476 at Page 501, and Book of Deeds 752 at Page 593.**
