NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

within the corporate limits of the City of Greenville, being known and designated as all of lot No. 18 and the northern one-half of lot No. 19, of a subdivision known as Vista Hills, recorded in the RMC office for Greenville County in Plat Book P at Page 149, and described as follows:

"BEGINNING at a point on the northwestern side of Ridgecrest Drive, at joint front corner of lots Nos. 17 and 18, said point being 335 feet southwest of the northwestern intersection of Wayne Street with Ridgecrest Drive, and running thence N. 69-15 W. 170 feet to point at joint rear corner of lots Nos. 17 and 18; thence S. 16-45 W. 112.5 feet to a point; thence S. 69-11 E. 164.3 feet to a point on the northwestern side of Ridgecrest Drive; thence with the northwestern side of Ridgecrest Drive, N. 20-45 E. 112.5 feet to the point of beginning."
