GEORGE ELBERT KENNEDY SEND GREETING:

Whereas, I, the said GEORGE ELBERT KENNEDY  
in and by MY certain Promissary note in writing, of even date with these  
Presents, am well and truly indebted to J.C.Roper, d.b.a., Southern Motor  
Finance Company  
in the full and just sum of Twenty-Four Hundred Ninety-Six and No/100 - - - -  
- - - Dollars, to be paid in weekly installments of \$16.00 per week  
until paid in full, beginning October 24, 1964,

, with interest thereon from maturity  
at the rate of 7 per centum per annum, to be computed and paid annually  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

consideration of the further sum of Three Dollars, to me, the said George Elbert Kennedy  
- - - - -, in hand well and truly paid by the said J.C.Roper, d.b.a., Southern  
Motor Finance Company  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bar-  
gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said  
J. C. Roper, d.b.a., Southern Motor Finance Company, his heirs and  
assigns, forever:

"ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Town-ship, being a portion of Lot No. 134, May No. 2, of Camilla Park, as shown on plat thereof, recorded in the R.M.C. Office for Greenville County in Plat Book "M", at Page 85, and being also known and designated as Lot No. 4, of a Subdivision of the Property of Talmer Cordell, as shown on Plat thereof, prepared by J. Mac Richardson, Surveyor, May 29, 1958, and recorded in the R.M.C. Office for Greenville County, in Plat Book "PP" at Page 123, and having, according to the last mentioned Plat the following metes and bounds, to-wit:

"BEGINNING at an iron pipe, at the northwest corner of the intersection of Welcome Avenue and Beatrice Street, and running thence along the northern side of Welcome Avenue, S. 59-30 W. 130.4 feet to an iron pipe at the joint front corner of Lots Nos. 3 and 4, as shown on the Richardson Plat aforementioned, thence along the joint line
