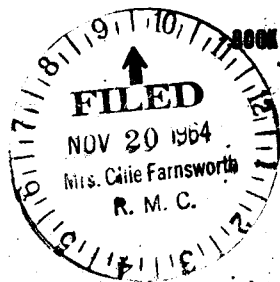

Edwards, his heirs and assigns forever; All that certain lot of land, with all improvements thereon, situate, lying and being in Greer Mill Village, in the City of Greer said state and county, and being more particularly described as lot No. 106 as shown plat entitled; Subdivision of Greer Mill Village, Greer, S.C. made by Dalton & Neeves January 1951, and recorded in the office of R.M.C. for Greenville County in plat Book Y at page 138 and 139, according to said plat, the within described lot of land is also known as No. 9 Gallivan Street and fronts thereon 76 feet.
