Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in the County of Greenville, State of South Carolina, on the Southeasterly side of Clemson Avenue, being shown and designated as Lot No. 7, Section "A", plat of property of Alice M. and H. H. Willis, recorded in the RMC Office for Greenville County, S. C., in Plat Book "K" at Page 271.

Said lot fronts on the Southeasterly side of Clemson Avenue 100 feet, has a depth of 318.8 feet on the Southerly side, a depth of 294.0 feet on the Northerly side, and is 103 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
