with interest thereon from date at the rate of six per centum per annum, to be computed and paid monthly, as stated above,

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hercof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Chick prings Township, Greenville County, State of South Carolina, on the west side of Sumter Street in the City of Greer, and being known and designated as Lot No. 43 on plat of Development No. 2, Victor-Monaghan Company, Division of J.P. Stevens & Co., Inc., Greer Plant, prepared by Dalton & Neves, Engineers, April, 1947, and recorded in the R.M.C. Office for Greenville County in Plat Book P, page 119, and having according to a recent survey by T.C. Adams, Engineer, the following courses and distances, to-wit:

BEGINNING at an iron pin on the northwest side of Sumter Street at the joint front corner of Lots Nos. 42 and 43, and the point of beginning being 375 feet to Carolina Street, and running thence with Sumter Street, S. 33-18 W. 100 feet to the front joint corner of Lots Nos. 43 and 44; thence with the line of Lot No. 44, N. 56-36 W. 190.7 feet to an iron pinin 10 foot alley; thence with said alley, N. 33-24 E. 100 feet to the joint rear corner of Lots Nos. 42 and 43; thence with the line of Lot No. 42, S. 56-36 E. 190.5 feet to the beginning corner.
