MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Vernon Whitmire, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

Nine Thousand and No/100------(\$ 9,000.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 46 of a subdivision known as Oak Crest, Section I, property of Brown, Inc., as shown on plat thereof prepared by C. C. Jones and Associates, Engineers, January 1955 and recorded in the R.M.C. Office for Greenville County in Plat Book GG at pages 110 and 111, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the corner of Lot No. 45 on the south side of Templewood Drive and running thence along the line of said Lot No. 45, S. 29-58 E. 150 feet to an iron pin at the rear corner of said lot in line of Lot No. 119; thence S. 60-02 W. 75 feet to an iron pin at the rear corner of Lot No. 47 in line of Lot No. 63; thence N. 29-58 W. 150 feet to an iron pin at the corner of Lot No. 47 on the south side of Templewood Drive; thence along the south side of Templewood Drive, N. 60-02 E. 75 feet to the beginning corner; being the same conveyed to me by Brown, Inc. by deed dated December 8, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 540, at Page 429."
