not less than Sixteen Thousand One Hundred Twenty-five Dollars in a company or companies
satisfactory to the mortgagee from loss or damage by fire, and the sum of Sixteen Thousand One  Hundred /Twenty- five loss or damage by tornado, or such other casualties or contingencies (including war damage), as may be required by the mortgagee and assign and deliver the policies of insurance to the said mortgagee, and that in the event the mortgagor shall at any time fail to do so, then the mortgagee may cause the same to be insured and reimburse itself for the premium, with interest, under this mortgage; or the mortgagee at its election may on such failure declare the debt due and institute foreclosure proceedings.
