ALL that certain piece, parcel or lot of land situate, lying and being on the Easterly side of Woodside Avenue near the City of Greenville, State of South Carolina and being shown as Lot No. 15 on the plat of Morgan Hill addition as recorded in the R.M.C. Offive for Greenville County in Plat Book A at pages 68 and 70, and also being more particularly shown as on a plat of the property of Dora L. Snipes Estate, et al., as recorded in the R.M.C. Office for Greenville County in Plat Book V, at apge 112 and having, according to last mentioned plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Woodside Avenue at a point 214.2 feet northeast of the northeasterly corner of the intersection of Woodside Avenue and Morgan Street, siad pin being the joint frontt corner lots 15 and 25 and running thence along the Easterly side of Woodside Avenue, N. 13-43 E. 64.3 feet to an # iron pin, joint front corner lots 14 and 15; thence with the joint line of said lots N. 82-45 E. 174.4 feet to an iron pin in the line of joint front corner lots 14 and 15; thence with the Lot.
