To All Whom These Presents May Concern:

I, Norris A, Roberts, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 91, Section 2 of a subdivision known as Western Hills as shown on plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book QQ at pages 98 and 99 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Tucson Drive, joint front corner of Lots 91 and 92; running thence with the joint line of said lots, S. 15-45 E. 202.5 feet to an iron pin; thence N. 73-32 E. 100 feet to an iron pin, joint rear corner of Lots 90 and 91; thence with the joint line of said lots, N. 15-45 W. 200.7 feet to an iron pin on the southern side of Tucson Drive; thence with Tucson Drive, S. 74-15 W. 100 feet to the beginning corner; being the same conveyed to me by Lloyd W. Gilstrap by deed of even date to be recorded herewith."
