Donahue recorded in the R. M. C. Office for Greenville County in Plat Book "CCC", at Page 19 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern corner of the intersection of Rogers Avenue and Arbor Street and running thence along the northern side of Rogers Avenue S. 83-45 W. 69 feet to an iron pin; thence N. 29-25 W. 258 feet to an iron pin; thence along the western side of Arbor Street the following courses and distances: S. 83-20 E. 64.7 feet to an iron pin; S. 59-10 E. 42.3 feet to an iron pin; S. 44-20 E. 74.5 feet to an iron pin; S. 37-45 E. 47.5 feet to an iron pin; S. 6-15 E. 100 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To Have and to Hold, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
