MORTGAGE

STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Martha S. Carpenter

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four Thousand Five Hundred and no/100----DOLLARS (\$ 24,500.00), with interest thereon at the rate of Five & one-half per dent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and an order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Balentine Drive in the City of Greenville, being shown and designated as Lot 10, and a part of Lot 9 of Greenbriar Subdivision, as shown on plat recorded in Plat Book E at page 87, and being more particularly described as follows:

BEGINNING at an iron pin on the northeastern side of Balentine Drive, at the joint front corner of Lots 10 and 11, and running thence with line of Lot 11, N. 56-50 E. 150.5 feet to an iron pin; thence N. 40-52 W. 117.3 feet to an iron pin in rear line of Lot 9; thence through Lot 9, S. 56-57 W. 131.1 feet to an iron pin on the northeastern side of Balentine Drive; thence with the northeastern side of Balentine Drive, S. 33-10 E. 116.5 feet to the point of beginning.

Said premises being the same conveyed to the mortgagor by dead recorded in the RMC Office for Greenville County in Deed Book 532 at page 357.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise of be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
