"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

KNOWN an designated as lot No. 105 of section 1 of Oak Crest as shown by a plat thereof made by C.C. Jones, engineer and recorded in the RMD office ofr Greenville County in plat Book GG, at pages 130 and 131 and having, accordint to said plat, the following retos & bounds:

Beginning at a point on the northern edge of Florida Av3. at the joint corners of lots 104 & 105 and running thence along the northern edge of Florida Ave, north 79-43 east 80 ft. to a point at the corner of Lot 106; thence a long the line of lot 106; north 9-57 west 182.2 feet to a point at the rear corner of lot 103; thence with the rear line of lot 103; south 33-38 west 120.4 feet to ap point at the corner of lot 104; thence with the line of lot 104; south 11-42 east 95.5 feet to the beginning corner.
