"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 3 of Rosewood Acres, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "MM", Page 154 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Brushy Creek Road, joint front corner of Lots Nos. 2 and 3 and running thence along the joint line of said lots S. 5-33 E. 165 feet to an iron pin and running thence along the joint line of Lots Nos. 3 and 16 S. 50-20 E. 149 feet to an iron pin; thence with the joint line of Lots Nos. 3 and 4 N. 5-26 E. 259 feet to an iron pin on the southern side of Brushy Creek Road; thence with the southern side of said road S. 89-40 W. 105 feet to the point of beginning.
