All that certain parcel or lot of land situated on the North side of West Poinsett Drive, on the West side of Bomar Street and the South side of the Old Chick Springs Road, in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, having courses and distances according to a survey and plat by H. S. Brockman, Surveyor, dated April 24, 1952, as follows, to wit:

Beginning at the intersection of West Poinsett Drive and Bomar Street on iron pin at the northwest corner thereof, and running thence along Bomar Street, N. 16.36 E. 294 feet to the intersection of said Bomar Street and the Old Chick Springs Road; thence along the south side of the Old Chick Springs Road, N. 70.59 W. 165 feet to an iron pin, corner of lot belonging to H. E. Dunean, et althence along line of same, S. 22.45 W. 165 feet to an iron pin; thence N. 87.37 E. 14.5 feet to iron pin; thence along line of Mrs. Martha Caldwell's property, S. 0.12 W. 189.7 feet to iron pin on north side of West Poinsett Drive; thence along same, N. 87.20 E. 122.5 feet to the beginning corner.

Office for Greenville County in Book 478, page 359, less however a small triangular lot on the rear (Western side) being conveyed to H. E. Duncan, et al. with following courses and distances: Beginning at rear corner of lot formerly owned by Mrs. Earle Duncan at iron pin and runs thence N. 87.37 E. 8 feet to an iron pin; thence N. 17.11 E. 77.6 feet to a point in common line with Robinson and H. E. Duncan lots; thence S. 22.45 W. 80.6 feet to the beginning corner.
