S. Highway No. 25 in the Town of Travelers Rest, South Carolina and being shown and designated as Lots Nos. 2 and 8 in a subdivision of properties of John Peterson and Lynell Peterson as shown by a survey made in January, 1955, and a revision of the lots dated 1958, both by Terry T. Dill, R.L.S. and a plat of same being recorded in the R.M.C. Office for Greenville County in Plat Book GGG at page 37, said plat being incorporated herein by reference hereto and made a part hereof, and having the following metes and bounds, towit:

Highway No. 25 at the joint front corner of Lot Nos. 3 and 2, and running thence S. 36-35 E. 200 feet to an iron pin, joint rear corner of Lots Nos. 2 and 8; thence N 53-25 E 90 feet to an iron pin, joint rear corner of Lot Nos. 2 and 9; thence N 36-35 W 200 feet to an iron pin on the eastern side of U. S. Highway No. 25; thence S 53-25 W 90 feet along the eastern side of U. S. Highway No. 25 to the point of beginning.
