"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in the subdivisoon known as Beechwood Hills being a portion of Lot #3 as shown by plat prepared by C. O. Riddle, entitled Map of Beechwood Hills, dated November, 1958, revised January 6, 1966, and having, according to said revision the following metes and bounds, to wit:
