"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Caroline, County of Greenville, being known and designated as Lot 5 on plat of Bradway Acres, recorded in the R. ft. C. Office for Greenville County, and having the following metes and bounds, to wit:

Beginning at an iron pin on Broadway Drive, running thence 502-10 E. 165.3 to an iron pin, thence N. 24-15 E. 66.7 to an iron pin thence 578-20 E. 167.3 to an iron pin on Broadway Drive, thence running with Broadway Drive; thence 80 feet to beginning corner.

Also beginning at an iron pin rear corner lot 5 and 6, running thence 582-10 E. 128 feet-5 to an iron pin on the back line of Broadway Acres running thence 5 8-1 to an iron pin. Running thence 578-20 E. 103-3 to an iron pin on rear corner of Lots 5 and 4 to an iron pin. Running thence with rear corner of lot 5, 68-7 to beginning corner.
