Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Six and 22/100-----Dollars (\$ 106.22), commencing on the first day of June, 19 66, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 96.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; on the southwestern side of Lancaster Lane and being known and designated as Lot No. 284, Section 3, Belle Meade Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "GG", Page 187, said lot being 80.1 feet across the rear, 128.4 feet on the eastern side, 128.4 feet on the western side and fronting 80.1 feet on Lancaster Lane.
