WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of ELEVEN THOUSAND AND NO/100ths---

DOLLARS (\$ 11,000.00), with interest thereon from date at the rate of six and one-half per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, composed of three portions of land, being lot 19 on plat of Newlands in Plat Book C at page 199 and a portion of Lot 4 of the property of Greenville County in Plat Book J at page 25 and a portion of the Old Paris Mountain Road and being more fully shown on plat entitled property of Herman E. Batson recorded in Plat Book OO at page 441 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of U. S. Highway No. 25 referred to as the Poinsett Highway at the corner of Lot 5 of Greenville County property which iron pin is situate 50 feet west of the center of the intersection of U. S.
