C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand Nine Hundred Fifty and No/100ths-

DOLLARS (\$ 12,950.00), with interest thereon from date at the rate of 6 3/4 per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Berea Section known as Lot 13 on Section 2 of the Subdivision of Richmond Hills, as recorded in the R.M.C. Office for Greenville County in Plat Book JJJ, page 81, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Portsmouth Drive at the corner of Lot No. 12 and running thence along said Drive N 28-34 E 100 feet to the corner of Lot No. 14; thence with said lot S 61-26 E 150 feet to an iron pin; thence S 28-34 W 100 feet to an iron pin at the rear corner of Lot No. 12; thence N 61-26 W 150 feet to the point of beginning.
