"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Spring Forest Road near the City of Greenville, being shown as Lot 49 on plat of Section II of Spring Forest recorded in the RMC Office for Greenville County in Plat Book BBB at page 34, and being further described as follows:
