"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the western side of Grove Road and being known and designated as Lot No. 8 on plat of Block O of O. P. Mills Property recorded in the R. M. C. Office for Greenville County in Plat Book "F", at Page 299 and having, according to said plat, the following metes and bounds, to-wit:
