TO ALL WHOM THESE PRESENTS MAY CONCERN: LINDSEY BUILDERS, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Nine Thousand and No/100-----

DOLLARS (\$ 9,000.00-----), with interest thereon from date at the rate of Six and three-fourths per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of Theodore Circle in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 6 on a plat entitled "Section No. 2 - Carolina Heights" dated October 1965, by Dalton & Neves Engineers and recorded in the RMC Office for Greenville County, South Carolina in Plat Book BBB at Page 161 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Theodore Circle at the joint front corner of Lot No. 6 with Lot No. 5 and running thence with the joint line of said lots S. 47-27 E. 150 feet to an iron pin on the line of property now or formerly belonging to Alexander; thence with the said Alexander property N. 42-33 E. 23.1 feet to a point on the line of property now or formerly belonging to Goodwin & Dempsey; thence with the said Goodwin & Dempsey property N. 0-58 E. 184.5 feet to an iron pin at the joint rear corner of Lot No. 6 with Lot No. 7; thence with the joint line of said lots S. 73-58 W. 103.2 feet to a point on the Southeastern side of Theodore Circle; thence with the Southeastern side of Theodore Circle S. 8-00 W. 40 feet to an iron pin; thence continuing with the Southeastern side of Theodore Circle S. 36-33 W. 40 feet to the point of beginning.
