WOHLFERD of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel, or lot of land on the Southwestern side of Theodore Circle, County of Greenville, State of South Carolina, being shown and designated as Lot No. 17 on a plat entitled "Carolina Heights - Section 2" dated October 1965, by Dalton & Neves and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book BBB at Page 161 and being further shown as Lot No. 17 on a plat entitled "Property of Glenn Leonard Wohlferd and Linda W. Wohlferd" dated February 9, 1967, by Campbell & Clarkson, Surveyors, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book MMM at Page 174 and having according to said more recent plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Theodore Circle at the joint front corner of Lot No. 17 with Lot No. 16 and running thence with the joint line of said lots S. 41-08 W. 120.1 feet to an iron pin; thence S. 48-52 E. 110 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence with the joint line of said lots N. 41-08 E. 150 feet to an iron pin on the Southwestern side of Theodore Circle; thence with the Southwestern side of Theodore Circle N. 48-52 W. 50 feet to an iron pin; thence continuing with the Southwestern side of Theodore Circle N. 78-45 W. 65 feet to the point of beginning.
