(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being all of that tract of land shown as Tract No. 7 on a plat made by C.O. Riddle, Surveyor, recorded in the R.M.C. Office for Greenville County in Plat Book JJJ, page 21, and having the following courses and distances:

BEGINNING at a point in the center of Bennett Bridge Road, common corner with Tract No. 6-B, and runs thence with the center of said road, N. 41-29 W. 502.6 feet to bend; thence N. 45-10 W. 1011.3 feet to a point in said road on the Summy line; thence with the Summey line as follows: N. 39-26 E. to iron pin (21.4)feet), S. 57-37 E. 339.8 feet, S. 50-21 E. 100 feet to pin, S. 38-10 E. 164 feet to pin, S. 46-58 E. 100 feet to stone; thence N. 26-38 E. 614.8 feet to stone; thence N. 58-51 E. 98.5 feet to stone, corner with Summey and Vinson; thence N. 37-07 E. 42.3 feet to an iron pin; thence S. 40-32 E. 432.9 feet to iron pin; thence S. 48-31 W. 658 feet to the beginning, containing 10.06 acres, more or less.
