TO ALL WHOM THESE PRESENTS MAY CONCERN:

James Thomas Floyd

SEND GREETING:

WHEREAS, I the said James Thomas Floyd

in and by my certain promissory note in writing, of even date with these Presents am well and truly indebted to CAMERON-BROWN COMPANY, a corporation chartered under the laws of the State of North Carolina, in the full and just sum of Seventeen Thousand Three Hundred Fifty and No/100 (\$17,350.00) DOLLARS, to be paid at its office in Raleigh, N. C., or at such other place as the holder of the note may from time to time designate in writing, as follows:

DUE AND PAYABLE ON DEMAND

with interest from the date hereof until maturity at the rate of Six and One-half (6 1/2 %) per centum per annum to be computed and paid semi-annually until paid in full.

Any deficiency in the amount of such monthly payments, shall, unless paid by the Mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. The Mortgagee may collect a "late charge" not to exceed an amount equal to five per centum (5%) of any installment which is not paid within fifteen (15) days from the due date thereof to cover the extra expense involved in handling delinquent payments.

All installments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any installment or installments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That I the said James Thomas Floyd

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CAMERON-BROWN COMPANY, according to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to me the said James Thomas Floyd in hand well and truly paid by the said CAMERON-BROWN COMPANY, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CAMERON-BROWN COMPANY.

ALL that piece, parcel or lot of land situate, lying and being on the northwestern side of Sherman Lane (formerly Davis Court) near the City of Greenville, in the County of Greenville, State of South Carolina and according to plat prepared by H. C. Clarkson, May 1, 1967 has the following metes and bounds, to-wit:

BEGINNING at a point on the northwestern side of Sherman Lane at the joint corner of this property and property of Otis Davis which point is 317 feet, more or less, from the center of the intersection of Sherman Lane and Plantation Road and running thence N. 42-53 W., 132.5 feet to an iron pin on the line of property of Rockhill Church; running thence with the line of that property N. 56-20 E., 140 feet to an iron pin in the line of property of Thomas James; running thence S. 38-0 E., 103.2 feet to an iron pin on the northwestern side of Sherman Lane; running thence with the northwestern side of said lane S. 43-55 W., 130 feet to an iron pin, point of beginning.
