"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

Located on the east side of Trade Street in the city of Greer, said State and County, and Chicks Spring Township, being shown and designated as Lot No. 3 of Marchant Place according to plat thereof as recorded in the R. M. C. Office of Greenville County, and having the following courses and distances:
