(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Alta Crest Drive and being shown as Lot 59 on a plat of Brook Forest subdivision dated May 14, 1958, prepared by Jones and Sutherland recorded in Plat Book QQ at page 17 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern side of Alta Crest Drive at the joint front corner of Lots 58 and 59 and running thence with lot 58 S. 37-11 E. 140 feet to an iron pin at the joint rear corner of lots 58 and 59; thence N. 52-49 E. 75 feet to an iron pin at the joint rear corner of Lots 59 and 60; thence with lot 60 N. 37-11 W. 140 feet to an iron pin on Alta Crest Drive; thence with said Drive S. 52-49 W. 75 feet to point of beginning.

This is the same property conveyed to the mortgagor by deed of August Hoverath to be recorded herewith.
