NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL those pieces, parcels or lots of land in Bates Township, Greenville County, State For South Carolina, in the Town of Travelers Rest, known and designated as Lots 10 and 11 of the Property of George W. Bridwell, shown on a plat thereoff made by T. T. Dill, Surveyor, Dated on March 1946, recorded in the RMC Office for Greenville County in Flat Book M at page 129, and being described together according to said plat, as follows:

Road/and Sycond Avenue, and running thence along Second Avenue, S. 16-09 1. 150 feet to an iron pin, joint rear corner of Lots 10 and 25; thence with the joint rear line of Lots 10, 11, 24 and 25, S. 69-40W. 100 feet to an iron pin, joint corner of lots Nos. 11, 12, 23 and 24; thence along the joint line of Lots No. 11 and 12, N. 16-09 W. 150 feet to an iron pin on the southern side of West Road, joint front corner of Lots 11 and 12; thence along the couthern side of West Road, N. 69-40 E. 100 feet to beginning corner.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
