WE, Robert E. Morgan and Lou Ella B. Morgan
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the Woodside Mills Village in the Town of Fountain Inn, Greenville County, South Carolina, and being more particularly described as Lot 81 as shown on a plat entitled "A Subdivision of Woodside Mills, Fountain Inn, S. C.", made by Piedmont Engineering Service, Greenville, S. C., October, 1952, and recorded in the RMC Office for Greenville County, S. C., in Plat Book BB, Page 83.
