TO ALL WHOM THESE PRESENTS MAY CONCERN:

Fred W. Kelly and Mary E. Kelly (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Six Thousand and no/100**-----DOLLARS (\$6,000.00), with interest thereon at the rate of **Seven** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **11** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All ~~that~~ ^{those two} certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Morgan Street and formerly O'Neal Avenue, being shown and designated as Lots 3 and 4 on plat of White City View recorded in Plat Book E at page 160 and described as follows:

BEGINNING at an iron pin on the southern side of Morgan Street at the joint front corner of Lots 2 and 3 and running thence with the line of Lot 2, S. 0-11 W. 150 feet to an iron pin; thence N. 79-43 E. 108 feet to an iron pin at the rear corner of Lot 5; thence with the line of Lot 5, N.0-20 W. 150 feet to pin on Morgan Street; thence with the southern side of Morgan Street, S. 79-43 W. 107.6 feet to the point of beginning.

This being the same property conveyed to the Mortgagors herein by deed recorded in Deed Book 758 at page 340.
