All that certain lot of land lying in the State of South Carolina, County of Greenville, at the corner of Strange Road and Confederate Circle (formerly known as Jebb Stuart Avenue) shown as Lot 29 on a plat of Sheffield Forest, Section Two, recorded in the R.M.C. Office for Greenville County in Plat Book BBB at page 61 and being further described as follows:

BEGINNING at an iron pin on the southern side of Confederate Circle (formerly known as Jebb Stuart Avenue) at the joint corner of Lots 29 and 49, and running thence along the line of Lot 49, S. 13-30 E. 107.3 feet to an iron pin at the corner of Lot 30; thence along the line of Lot 30, S. 52-10 W. 110 feet to an iron pin on the eastern side of Strange Road; thence along Strange Road, N. 47-25 W. 60 feet to an iron pin; thence continuing along Strange Road, N. 42-51 W. 60 feet to an iron pin; thence along the curve of the intersection of Strange Road and Confederate Circle, N. 15-23 E. 34.1 feet to an iron pin on the southern side of Confederate Circle; thence along Confederate Circle N. 63-20 E. 85 feet to an iron pin; thence N. 77-05 E. 64.4 feet to the point of beginning.
