"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of <u>Greenville</u>
at the northeast intersection of Edwards Road and Ike's Road, in Chick Springs Township, being shown and designated as Lot No. 3 on plat of property of James F. Finley, made by J. Mac Richardson, May 1959, recorded in the RMC Office for Greenville County, S. C., in plat book SS page 165, and having according to said plat and a survey by R. K. Campbell, dated Jan. 12, 1960, the following metes and bounds, towit:
