NOW, KNOW ALL MEN, That the Mottgager, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgager may be indebted to the Mortgager at any time for advances made to or for his account by the Mortgager, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgager in hand well and truly paid by the Mortgager at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgager, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as 10tB 2V, 21 and 22 on a plat of Hunters Acres prepared by W. J. Riddle, Surveyor, dated May, 1952, and recorded in Plat Book BB, Page 51, in the RMC Office for Greenville County and having such metes and bounds as appear thereon.

This mortgage is second and junior in lien to that certain mortgage given to David I. Horowitz of record in the Office of the RMC for Greenville County in R. E. M. Book 1124, Page 599.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and af all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fixted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
