WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpald for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, as it he option of the holder thereof become immediately due and payable, and said holder shall have the right to Institute any proceedings upon said note and any collateral given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which truty be advanced by the Mortgage to the Mortgagor's account, and siso in consideration of the sum of Three Dollars (33.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvement, thereon, or hereafter to be constructed thereon, stude, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 97 on a plat of Kingsgate by Pledmont Engineers and Architects, recorded in the RMC Office for Greenville County in Plat Book WWW, Pages 44 and 45, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the southern side of Rushden Drive, joint front corner of Lots 96 and 97, and running thence along the line of said Lots 8. 23-35 E. 150.00 feet to a pointin the line of Lot 100; thence running S. 66-25 W. 125.0 feet to a point, in line of Lot 99, joint rear corner of Lots 97 and 98; thence along the common line of said Lots N. 23-35 W. 150.0 feet to a point on the southern side of Rushden Drive; thence along said Rushden Drive N. 66-25 E. 125.0 feet to the point of beginning.
