WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 52 on plat of Sector II of Botany Woods recorded in Plat Book QQ at page 79, and having the following metes and bounds:

Beginning at an iron pin on the eastern side of Botany Road at the front corner of Lots 51 and 52; thence S 89-25 E 200 feet; thence N 29-08 W 128 feet; thence N 83-25 W 130 feet; thence along Botany Road, S 6-15 W 27.6 feet; thence continuing with Botany Road, S 3-19 W 97.4 feet to the point of beginning.

Being the same property conveyed to the mortgagors by deed of Helen C. Moskos to be recorded herewith.
