NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the eforesaid debt, and in order to secure the payment thereot, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor et any time for advances made to or for his account by the Mortgagor and also in consideration of the further sum of Three Dollars (3,00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledgod, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Croline, County of Treenville, in Treenville Township, about two miles and a half northwest of Greenville Court House, lying between the Paris Mountain Road and the road leading from the American Spinning Company to Paris Mountain Road, and having the following boundaries:

BEGINNING at an iron pin on a street at the corner of lot of J. N. Smith and running thence with the south aide of said Street, N. 56g W. one hundred feet to an iron pin; thence S. 23g W. one hundred ninety-five feet, more or less, to a stake; thence S. 56g E. one hundred feet to a stake in line of J. N. Smith; and thence with his line, N. 23g E. one hundred ninety-five feet, more or less, to the beginning conner, and known as Lot Number seven on plat made by W. A. Hudson, D. S.
