NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns: FOREVER:

All that lot of land situate on the western side of Spruce Street in the County of Greenville, State of South Carolina being shown as Lot 12 of Block 12 on a plat of Woodville Heights recorded in Plat Book L at pages 14 and 15 and also in Plat Book K at page 273 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNNIG at an iron pin on the western side of Spruce Street at the joint front corner of lot 12 and lot 13 and running thence with lot 13 N. 87-30 W. 215 feet to an iron pin at the joint rear corner of lot 8 and lot 9; thence with lot 9 N. 3 E. 70 feet to an iron pin at the joint rear corner of lot 11 and 12; thence with lot 11S. 86 E. 218.2 feet to an iron at the joint front corner of lot 11 and lot 12; thence with a 10 foot sidewalk S. 5-15 W. 68.1 feet to the point of beginning.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
